

This Agreement is made between **LuvNote LLC** ("Developer") and the undersigned ("Pioneer") regarding the promotion of the **SingleGrain VST3 Plugin**.

1. The Partnership Role The Pioneer is invited to participate as a featured partner in the SingleGrain launch and ongoing promotion. This is a non-exclusive relationship. The Pioneer is an independent contractor, not an employee of LuvNote LLC.

2. Revenue Share and Incentives

- **Pioneer Commission:** Developer will pay the Pioneer __% of the net revenue (gross sales minus payment processing fees and applicable taxes) for every sale attributed to the Pioneer's unique discount code. **This commission applies strictly to the sale price of the software; any optional tips or "pay-what-you-want" additions provided by the customer are excluded from the Pioneer's revenue share.**
- **Customer Discount:** The Pioneer's unique code will provide the end-user with a __% discount off the current retail price of SingleGrain.
- **Product Access:** Developer will provide the Pioneer with one (1) lifetime NFR (Not For Resale) license for SingleGrain for promotional and personal use.
- **Feature Opportunity:** Pioneer partners are eligible to have their content featured on LuvNote's official social channels and website at Developer's discretion.

3. Tracking and Analytics

- **Transparency:** The Pioneer will have access to a partner dashboard to monitor performance. This dashboard will display total sales and total revenue (excluding tips) for the trailing 90 day period.
- **Payment Visibility:** The dashboard will also display the Pioneer's current pending payout balance and the scheduled date for the next payout.
- **Attribution:** Sales are tracked via the specific discount code entered at checkout.

4. Payment Terms

- **Frequency:** Payouts will be issued bi-weekly (every 14 days).
- **Method:** Payments will be sent via **PayPal** or **Zelle**, as designated by the Pioneer.
- **Minimum Payout:** There is no minimum payout threshold.
- **Tax Documentation:** Pioneer agrees to provide a completed Form W-9 to the Developer. **Upon reaching a cumulative payout of \$500.00, the Developer will pause all future payments until a valid Form W-9 is received.** Developer will issue a Form 1099-NEC for total annual payments exceeding \$600.00 as required by law.

5. Content and Conduct

- **Creative Freedom:** The Pioneer has full creative control over how they showcase SingleGrain.
- **Honesty:** The Pioneer agrees to provide honest reviews and demonstrations.
- **FTC Compliance:** The Pioneer agrees to disclose the partnership where required by law, including using #ad or equivalent disclosure in video descriptions and social posts.
- **Brand Integrity:** The Pioneer will not associate the SingleGrain name with piracy, crack, or warez related content of any kind.

6. Term and Termination

- **Termination Without Cause:** Either party may terminate this agreement for any reason by providing **fifteen (15) days** written notice via email.
 - **Termination For Cause:** Developer reserves the right to terminate this agreement **immediately and without notice** if the Pioneer violates the Brand Integrity or Conduct standards (Section 5), or engages in illegal activity.
 - **Final Payout:** Upon termination, the Pioneer's discount code will be deactivated at the end of the notice period. Developer remains obligated to pay all commissions earned for valid sales attributed to the Pioneer's code up to the effective date of termination. These final payments will be issued in the next scheduled bi-weekly cycle.
